More Than 1,300 Greyhound Injuries Have Been Reported at Gulf Since 2008

Between January 1, 2008 and August 4, 2011 a total of 1,351 greyhound injuries were reported at Gulf Greyhound Park.¹

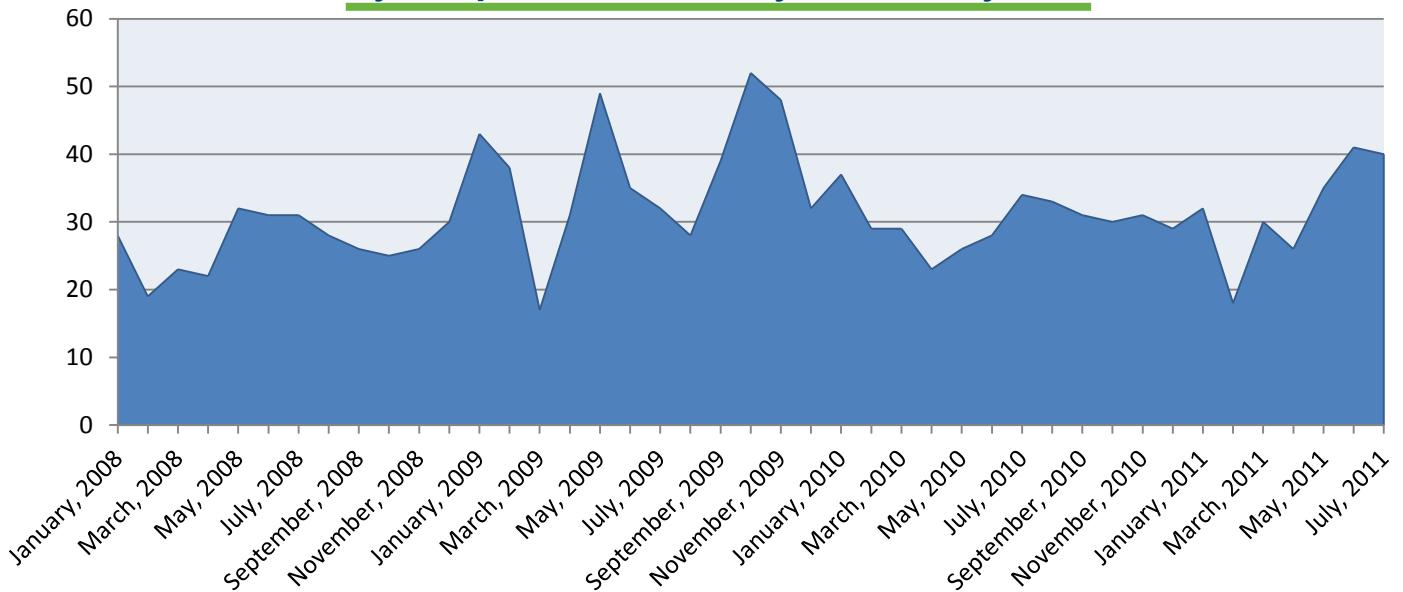
Injury Rates Remained Relatively Stable

During this period, an average of 31.33 injuries per month were reported.² The highest number of reported injuries for a single month occurred in October 2009, when 52 were reported.³ The lowest number of reported injuries occurred in March 2009, when 17 were reported.⁴

Injuries per month, January 2008 to July 2011



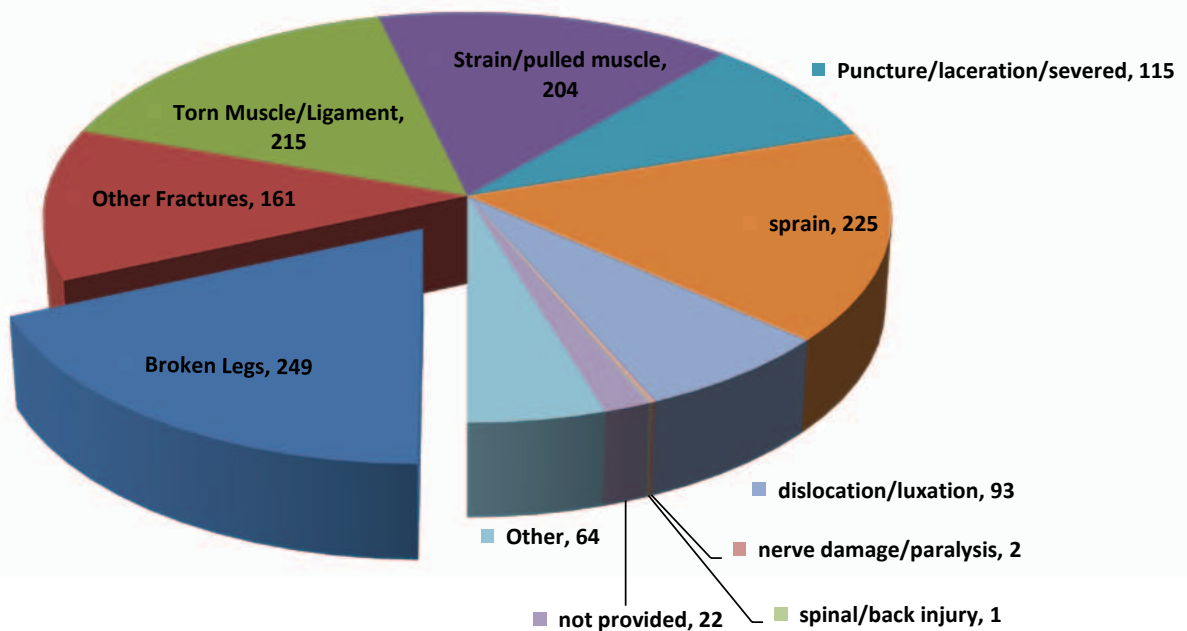
In a handful of cases, multiple injuries were reported for the same dog on the same day.⁵ In 33 cases, a greyhound was reported injured on at least three separate occasions.⁶

The Most Commonly Reported Injury Was a Broken Leg

The most commonly reported injury was a broken leg. Specifically, 249 or 18.4% of all reported injuries involved fractured legs.⁷ Other reported injuries included torn muscles, puncture wounds, lacerations, dislocations, sprains, paralysis and a fractured skull.⁸

Types of Injuries



Various Causes of Injury Were Indicated

According to state records, greyhounds at Gulf were injured during this period due to various causes. This included dogs that were “pushed into (the) rail,”⁹ “stepped on,”¹⁰ collided with other dogs,¹¹ fell,¹² rolled,¹³ jumped into the rail,¹⁴ were “caught in fence,”¹⁵ “hit hard,”¹⁶ “caught in (the starting) box,”¹⁷ “hit lure,”¹⁸ “slipped,”¹⁹ “collapsed on track,”²⁰ and suffered a “spike wound.”²¹

49 Greyhound Injuries Resulted in Death or Euthanasia

In total, 49 greyhound injuries resulted in death or euthanasia.²² For example:

- On April 28, 2011 a two-year-old white and brindle greyhound named MW Fey One was euthanized after suffering a broken leg during a race.²³
- On March 16, 2011 a one-year-old red brindle greyhound named Bob's Lawson was euthanized after he collided with other dogs during a race and suffered a compound fracture in his right front leg.²⁴
- On Valentine's Day 2011 a two-year-old brindle greyhound named Crispins Place was euthanized after suffering a broken leg during a race.
- On August 14, 2010 a three-year-old red greyhound named Grumby Fearless was euthanized after suffering a broken leg. There was also evidence that she had suffered a previous injury.²⁵
- On August 6, 2010 a three-year-old red brindle greyhound named Gable Weeman was euthanized after suffering a broken leg during a race.²⁶
- On July 28, 2010 a two-year-old brindle greyhound named Slint was euthanized after suffering paralysis in her hind legs during a race.²⁷
- On April 30, 2010 a one-year-old greyhound named Rags Patches was euthanized after she "fell as the result of a racing accident," broke her neck and was paralyzed.²⁸ Two months earlier, on February 25, a sister of Rags Patches named Rags Carla was euthanized after she broke her right front leg during a race.²⁹

- On August 12, 2009 a one-year-old black greyhound named Bob's Brian died after he hit a pole during a race and suffered a fractured skull.³⁰
- On May 21, 2009 a three-year-old red fawn greyhound named ReDeem was euthanized after suffering a broken leg and a ligament tear during a race.³¹
- On February 25, 2009 a two-year-old red fawn greyhound named JIT Galaxy Laser died after suffering a broken neck during a race.³²
- On January 3, 2009 a three-year-old brindle greyhound named J's Dawn died after suffering a heart attack during a race.³³
- On October 31, 2008 a three-year-old brindle greyhound named U Too Wood was euthanized after he suffered a broken back during a race and collapsed on the track.³⁴ According to state records U Too Wood was injured on two other occasions before his fatal injury, including a broken leg he suffered only sixteen weeks earlier.³⁵ Also on October 31, 2008, a three-year-old black dog named SP's Bradshaw, was euthanized after he suffered "multiple fractures" in one of his back legs during a race.³⁶
- On October 7, 2008 a four-year-old red greyhound named RPs O'Bannon died after collapsing following morning schooling. Her abdomen had ruptured and filled with blood.³⁷
- On April 3, 2008 a four-year-old fawn greyhound named P's Strawboss was euthanized after suffering a broken neck during a race.³⁸
