Dear Mr. Kogan,

Please consider this a formal request for investigation.

This afternoon, we received a confidential tip regarding a greyhound at Sarasota Kennel Club named Raiders Uncle Mo. According to our source, Raiders Uncle Mo fell into the track rail and was electrocuted during a race on this past Saturday, February 9. According to TrackInfo.com, Raiders Uncle Mo was entered in the second matinee race on that date, and assigned the #2 box.<sup>1</sup>

There is evidence that this incident did in fact occur. After reviewing video footage from this race, Raiders Uncle Mo can clearly be seen falling into the rail a few seconds after the race began.<sup>2</sup> Further, TrackInfo.com indicates that in this race Raiders Uncle Mo "Hit, fell Early, dnf."<sup>3</sup>

Our source also indicated that another dog was electrocuted and died a few weeks earlier after suffering a similar injury at Sarasota.

We would appreciate it if you would investigate this incident promptly. Thank you in advance for your consideration of this request.
